

**ENTRY LIMIT**: 9 TDU dogs

**ENTRY FEE:** \$75.00 per TDU entry. Make checks payable to APOTC.

**ENTRY FORM**: Entries must be on official AKC entry forms or a photocopy of same including the reverse side with agreements and rules. Unsigned entries cannot be accepted.

**TEST HOURS**: From 6:00 AM to 6:00 PM or until last dog has been judged.

WORKER DRAW: A worker draw will be used for this test in accordance with the worker draw parameters set forth in Chapter 1 Section 17d of the Tracking Regulations and as determined by the APOTC Tracking Committee and Board. Three (3) TDU tracks will be set aside for workers at this test. To be eligible for the worker draw, an APOTC worker draw coupon must accompany the entry.

ENTRY DRAWING: In accordance with Chapter 1 Section 17 of the AKC Tracking Regulations, a drawing to fill entry limits will be held at 10910 Silverthorn Rd, Edinboro, PA 16412 on Thursday, October 10 at 8:00 PM. This drawing is open to all interested persons. Priority will be given to dogs that do not hold the TD or TDU title. Alternates will be given the option to accept or decline a place on the alternates list. Those who accept will be placed on the alternates list in the order in which they were drawn. Those who opt to decline will have their entry fees returned. Entrants and alternates who do not run in a test but are replaced by alternates who run in the test will have full entry fees returned. Following the draw, the test secretary will attempt to contact all entrants and advise them of the outcome within 48 hours. E-mail and telephone inquiries are welcomed. In the event an accepted entry is absent on the day of the test, the first alternate entry present according to the order in which they were drawn shall assume the vacant position.

**BITCHES IN SEASON MAY PARTICIPATE:** Entrants must notify the Test Secretary and Judges that their bitch is in season prior to the draw for tracks. Bitches in season will participate only after all the other dogs have been tested.

**ELIGIBILITY:** TDU entries for dogs without either a TD or TDU title must include an original statement (certification) dated not more than two years prior to the test date, signed by an AKC Tracking Judge or evaluator in accordance with Chapter 3 section 2 of the AKC Tracking Regulations, stating that the dog is considered to be ready to participate in a TD or TDU tracking test. Dogs without a TD or TDU title will be given priority in the TDU test. All-American, AKC Canine Partner registered dogs are eligible to enter.

**DRAW FOR TRACKS**: The draw for running order of TDU tracks will take place at 7:30 AM on the day of the test at the Test Headquarters.

#### **AGREEMENT**

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

#### **INSTRUCTIONS**

- 1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- 2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- 5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
